4. Determination of next steps for topic areas
 - Sexual Assault on Campus
 - Several campus areas are working on sexual assault (e.g. The Aurora Center, IFC, MSA)
 - Boynton Director of Research is involved with working on the University's campus climate assessment tool
 - It is important to create a fluid conversation with a unified vision. SHAC can help with this task.
 - October 23: MSA is hosting a conversation about a sexual assault campaign. SHAC and Boynton representatives will be in attendance. Many other campus departments will be there as well.
 - UPass for Metro Mobility
 - Abdi followed up with Metro Mobility. Metro Mobility will start installing card readers that will work with Go To cards. UPasses will not work with these readers because they do not have a stored monetary value.
 - Next step: collaborate with other departments to send a letter (including rationale and the request) to the Met Council.
 - Ross Allanson from Parking and Transportation Services would be a great contact. Dave will initiate this contact.

 - Occupational Health issues for students
 - The sub-committee should meet with Paul Allwood from EHS to start the conversation
 - Sub-committee: Addie, Cameron

 - A number of departments are looking at this topic
 - Initial meeting should be with OHR Benefits to identify barriers
 - A student senator is interested in helping

5. Student Service Fees recommendations regarding BHS funding model including third party reimbursements
- Fees information is due to the SSF Committee around the 3rd week of January
 - SSF request presentation usually takes place the 1st week of February
 - SHAC representatives will help with the proposal and give the presentation
 - Boynton is looking at how health care reform has impacted our budget. In particular, reimbursements from insurance companies have decreased because of health care reform.
 - Possible recommendations: Increase SSFs that Boynton requests or change the way that Boynton uses SSFs
 - Boynton has tried really hard to remove financial barriers to students accessing health care. However, students who choose insurance plans with high deductibles are using more of the SSFs. The committee should consider how best to handle this situation.
 - Participation in this sub-committee is a great opportunity!

6. Hours of Operation for Boynton Health Service
- 7:45-5:00 M, T, W, F
 - 9:00-5:00 Thursday
 - 9:00-1:00 Saturday during fall and spring semesters when classes are in session
 - Boynton would like to be as accessible as possible to students while also making good financial decisions
 - Boynton's hours were set to increase access but we aren't certain they actually do increase access as opposed to spreading out appointments
 - Holding Saturday hours costs Boynton money: \$25,000-\$30,000 per year
 - Holding Saturday hours was meant to add access and convenience for students and not to make money but the amount of money lost keeps increasing
 - Biggest benefit of being open on Saturday is for those few students who utilize urgent care services
 - Boynton is also assessing the hours of operation during the week to make sure we are providing cost-effective care that is as convenient as possible
 - The campus is most populated with students between 10 am and 2 pm
 - Students on the University's SHBP would be covered at 80% if they went to Fairview if Boynton was closed. If students are on a different plan, it would depend on the plan
 - Out of approximately 38,000 fee-paying students, about 10,000 students are on the SHBP and about 8,000 students are on the graduate assistant plan
 - Students have access to a 24-hour nurse line for non-emergencies
 - The 24-hour nurse line number should be added to the After Hours brochure
 - Boynton will likely discontinue offering Saturday hours but the final decision has not been made.
 - Boynton would like to make pharmacy service accessible and convenient
 - Boynton is looking for other ways to improve student access to Pharmacy service outside of Boynton hours of operation
