1. Welcome and Introductions – (Abdi & Sky)
2. Review of Minutes from 11.19.15 (Abdi & Sky)
  - No changes.
3. Danita Brown Young attending SHAC on 1.21.15
  - She will provide a brief overview of OSA's goals
  - Opportunity for SHAC members to meet with senior leader on campus
4. Flu Vaccine
  - Dave provides update that about 60% of our student population has been vaccinated within the last 12 months
  - By the end of flu season about 23,000 flu shots will be provided on campus
5. Student Health Benefit Plan Advisory Committee update
  - There are few items about the health plan that The Office of Student Health Benefits would like input on
  - The advisory committee will include people who are currently covered under the SHBP as well as other leaders around campus.
  - Email will be sent to all students on all campuses to encourage participation
  - Meetings are scheduled for January and February
  - December 18<sup>th</sup> is the deadline for participation
  - Committee will include orientation and terminology, weighing changes in benefits, comparing our plan to other plans on the market.
6. Survey data recap
  - Are there things that stuck out and are there things you'd like to see more data on?
  - An Nyugen and his group would like more clarification on why the sexual assault numbers have jumped.
  - Dave shares that BHS reviewed the numbers in reports from other schools over the past few years and looked at national numbers as well and sexual assault numbers in these areas have also jumped which says that this jump is not specific just to UMN.
  - The experts on campus believe this jump is due to under reporting in the past based on peoples own awareness of what sexual assault is. Clearer understandings could mean these numbers are more accurate than numbers we've seen in the past.
  - Ryan asks if there is a centralized place where sexual assaults are reported. The group responds that it is up to the victim to decide if and who they report the assault to. Conversations continue about supporting the victim survivor, maintaining confidentiality and having reports of all sexual assault whether charges are filed or not.
  - Dave proposes that there may be other consequences that the University could institute outside of the legal system if all cases were reported to a centralized location.
  - Julie shares that there is a University reporting system for ethics that someone who violates the law or University policy can be reported to confidentially. That system is called UReport
7. Food insecurities and grocery store shuttle
  - MSA wants to initiate a weekend shuttle to and from the grocery store (story in the MN Daily 12.3.15)
  - Still need to establish the need, what the goals of this project would be and if this would work for students.
  - An asks who this would be targeting and how this would be better than current public transportation. Would it be better/easier to argue to increase the campus zone with Metro Transit. An can connect with a renters group if the group we are targeting are apartment residents near campus.
  - Boynton will further run the food insecurities data from the survey to better understand who this impacts.

8. Boynton patient satisfaction data
  - COGS is interested in looking at this data to see if there is an area we could impact.
  - Data is can be broken down by the service/department and shared at their request.
  - Mostly this information is not shared because no one asks for it not because we aren't willing to share.
  - Data can be run by populations as well (GLB, international, etc)
  - Provide data to SHAC at a later date. Invite Dr. Katie Lust to return to another meeting.
  
9. SHAC member updates
  - Many members would like SHAC to continue work on mental health/mental illness and support the work that MSA has planned.
  - Maddie mentions the work that Aurora is beginning on men's engagement and this may be an area SHAC could get involved in
  - Ryan requests efforts to be more goal oriented and push projects forward.
  - An would like sleep zones to be back on the agenda for SHAC.
  - All current SHAC members plan to participate again next semester with the exception of Brook Leaf- Health Advocates.
