- Faculty consultative council is voting today, the full senate will vote May 2. The full senate is comprised of students, staff and faculty.

- Have not seen the sexual assault mandate yet/ there is no known date when it will be available.
- 2 parts to the survey
  - Education 1.5 hours to complete
  - Financial literacy module- 1.5 hours to complete.
- Students will be expected to complete the survey
- 2 year contract. BHS is responsible for the implementation.
- No credit is available
- Soft requirement- no consequences if not completed.
- At this time there are no plans to put holds on records
- E-mail reminders will be sent.

- Working with housing coordinators of the SOBER club to develop a sober house
- Different criteria than substance free housing.
- Will be in a designated area with an existing or new residence hall
