- 1. Welcome and introductions (Mo)
- 2. Review of minutes from 1.30.18
 - a. No changes
- 3. Student Service Fee Request
 - a. Student Service Fee Presentation happened on Friday, February 9th
 - b. Other units are presenting this Friday and then a public forum will occur
 - c. By all accounts the presentation went well and fees will likely be approved
- 4. Couples Counseling
 - a. Average of about 25-30 initial couples visits over the last few years
 - b. Couples average 3 follow up visits
 - c. 19% who had an initial visits didn't return for a follow up visit, 33% came for one follow up visit, the rest came for 4-19 additional visits
 - d. Higher late cancel rates: 21% late cancel rate for couples sessions compared to 11-12% for individual visits
 - e. Plan is to work on the service delivery model for couples counseling. Will work with current mental health staff who are more specialized in working with couples to put this together this summer.
- Assessing student groups
 - a. Proposed using a google form to collect information from groups about health needs on campus
 - i. What do you think are the top health related issues facing student at the University of Minnesota?
 - ii. What issues do you see having the greatest impact on students and their academic goals?
 - iii. Do you think access to healthcare is adequate?
